Jobs.... in Public Health (BLS, 2023)

- By 2030, the United States will need more than 250,000 additional public health workers at the federal, state, and local levels
- 1.8 million openings are projected each year.
- projected workforce shortages could be about 25%...
 - 5-11% growth in public health careers*
 - Worldwide net shortage is about 15million professionals (wнo,2023)
- We will need to graduate three times the current number of graduates over the next 10 years to replenish the workforce

Master of Public Health – Cumulative Experience

• Applied Practice Experience (3cr) – Field Studies

- CHS 798 : The Practicum provides the opportunity for students to integrate their classroom learning into experiential learning.
- This planned, supervised, and evaluated experience provides a dynamic environment for students to work with experienced professionals in public or private organizations that address significant global health issues.
- Practicum is designed and implemented to ensure that students gain competence in public health practice relevant to the concentration area the student selected.
- Thus, practicum should be undertaken in an organization, agency, department or community that provides planning and/or services that reflects public health and specifically in concentration area.



Master of Public Health – Cumulative Experience

- Integrative Learning Experience (3cr) MPH Capstone CHS 796
 - CHS 796 is a culminating course, an interdisciplinary practice-based MPH project undertaken by last term students, providing evidence and recommendations to stakeholders for the development of policies and advocacy.
 - purpose of this course is to make direct and indirect connections between the content of the core courses and the practice of public health, in particular making policy recommendations to the government/stakeholders through a holistic learning experience
 - bridging the gap of theory and practice and achieving a better understanding of the complexity and inter-sectoral nature of public health
 - course draws the preparation from each of the core courses in the entire program, where students use the tools from the class to complete assignments



Master of Public Health – Cumulative Experience

- Vast network of individuals throughout the community provide students with lifelong opportunities to gain real-world experience while making a lasting impact on public health
- Unique location, resources and opportunities help create a rich educational environment for graduate students
